Students must complete the "Education on Academic and Research Ethics" course and take the exam to obtain the certificate from the Center for Taiwan Academic Research Ethics Education website. Each department may additionally require the completion of professional academic research ethics education workshops, which will be implemented according to the regulations established by each department. Students who fail the oral defense within study period should retake it next semester or year. If students who retake the oral defense fail again, their studies will be terminated. The score of the retaken oral defense is uniformly calculated at 70.
 XI. Other: English proficiency graduation requirements: (Specify if the department/graduate institute has no set requirements) 1. Prior to applying for the dissertation defense, students must have published (or had accepted) at least two papers in SCI-indexed journals, or at least one SCI paper with a total impact factor of 4.0 or higher. The student must be the first author 2.Before graduation, students must present their research at least three times at domestic or international academic conferences. 3.
